Terms & Conditions

1. Contracting partners

The study contract is concluded with the Institut Supérieur de l'Économie-Akademie der Wirtschaft (ISEC-AdW), société anonyme (limited liability company); hereinafter referred to as ISEC-AdW. ISEC-AdW is registered with the Registre des Commerces et de Sociétés Luxembourg (RCS-L) under B201309. ISEC- AdW is represented in and out of court by its board (Directoire). ISEC-AdW has its registered office and address at 7, rue Alcide de Gasperi in L-1615 Luxembourg.

ISEC-AdW is the holding company of the Institut Supérieur de l'Économie-Hochschule der Wirtschaft; in the following ISEC. The ISEC is accredited by the Ministry of Higher Education and Research Luxembourg.

2. Jurisdiction and applicable law

Jurisdiction is Luxembourg and applicable law is Luxembourgish law, subject to other regulations.

3. Study fees

The study fees for all study programmes are due at the beginning of the first semester. Monthly instalments can be agreed.

4. Written form

Registrations, revocations, and other changes must be made in writing. Verbal agreements have no legal effect.

5. Cancellation deadlines

If a participant unsubscribes from the programme before the start of the study programme in compliance with the following cancellation deadline, a processing fee of 75,00€ will be charged. The cancellation must be introduced in writing no later than 6 weeks before the beginning of the study period.

6. Cancellation or extension of a semester

- In the case of study programmes with a duration of over 6 months, a cancellation is possible at the end of each semester with a notice period of 6 weeks.
- b. Extension semesters are subject to a fee and must be requested in writing at least 6 weeks before the beginning of the semester. If there are still examinations to be completed in the extension semester, tuition fees in the amount of half of the regular tuition fees of a semester must be paid.

7. Start of a study programme

The start of a study programme depends on a minimum number of participants, which may vary depending on the programme and/or the start of the semester. If the minimum number of participants is not reached, ISEC-AdW reserves the right to terminate the study contract or to offer the student to postpone his/her studies to a later semester. In addition to the claims for reimbursement of fees already paid, there are no further claims of the participant.

8. Programme modifications, relocations, or dismissal

Programme changes, relocation or cancellation of events are also reserved. In addition to the claims for a reimbursement of fees already paid, there are no further claims admissible.

9. Offered degree

Upon successful completion of the study programme, the student will be awarded the German degree "Master of Business Administration" by the FOM Hochschule für Oekonomie & Management. The FOM is system accredited by the Foundation for International Business Administration Accreditation (FIBAA) therefore this study programme is also accredited.

10. Data storage
